

Rojo Pacific Limited Warranty

ROFAB Multi Cover 650[®], ROFAB Multi Cover PLUS 650[®], ROFAB Tent Wall 650[®], ROFAB Tent Roof 850[®], ROFAB Riplock 680[®], ROFAB Unicoat 900[®]



Rojo Pacific stands behind our industrial fabrics with a 7-Year Minimum Limited Warranty for ROFAB Riplock 680[®], ROFAB Unicoat 900[®], ROFAB Tent Wall 650[®], ROFAB Tent Roof 850[®] & ROFAB Multi Cover PLUS 650[®] and a 5-Year Minimum Limited Warranty for ROFAB Multi Cover 610[®].

Rojo Pacific warrants against fading*, cracking, splitting & delamination due to polymer breakdown. All Warranties commence from the date on which the PVC is purchased. Rojo Pacific may vary the Warranty depending on the intended application and the colour of fabric chosen*. Such variations will be notified at the time of purchase.

Under this Warranty, Rojo Pacific will, at its discretion, replace the fabric free of charge OR, where deemed practical by Rojo Pacific, replace the faulty section of the fabric, OR credit the value of the PVC fabric or fabric section in question. This Warranty does not extend to any compensation for any consequential loss or damage[‡].

* Colour fastness varies according to the colour of fabric chosen and the application. Lighter colours, particularly those containing red pigment, will fade faster and attract a reduced warranty of 5 years for acrylic lacquered products and 1-2 years for non-lacquered product. Please check the suitability of your chosen colour for the desired application and check warranty details at the time of product selection.

Excluded from this limited Warranty are damage or defects due to:

- normal wear of the fabric
- deterioration relating to mistreatment, improper handling or maintenance of the fabric
- unusual climatic or temperature exposure
- improper installation by a party other than Rojo Pacific
- modifications to the fabric not carried out by Rojo Pacific (eg. Sewing of the fabric)
- use in applications against specific advice from Rojo Pacific[†]
- any other factors considered by Rojo Pacific to be unreasonable for the fabric to withstand.

Any claim under this Warranty must be notified to Rojo Pacific within 10 days of the defect being noted, and the fabric must be made available to Rojo Pacific, their agents and/or their insurance company, for inspection. Replacement of the defective fabric, or fabric section, does not extend the duration of the original Warranty.

‡ The value of the replacement or reimbursement offered will be pro-rata proportional to the time elapsed on the warranty.

† We recommend thorough testing prior to the purchase of any product, and will provide advice and assistance in selecting the most suitable fabric specification and colour for the application required, as well as any reasonable laboratory testing required to support product selection.
